letter from david

Dear Redeemer West Side,

Certain principles in Scripture are easier to remember than experience or practice. Like *turning the other cheek*, or *the last shall be first*. One of those principles that has slowly become part of my experience and practice over the last few years is God's *strength is made perfect in our weakness* (2 Corinthians 12:9). When I look back at where Redeemer West Side was prior to the pandemic and where we are now, having emerged stronger from that crucible, the only explanation is God's strength made perfect through our weakness. I have no other plausible explanation than God's grace and love for his church. Standing on stage each week, flooded by our congregation's singing, meeting new people in the lobby, seeing us grow in both number and depth is God's testimony to me (and I hope many of you) that he uses our weakness to demonstrate his glory and goodness.

This Annual Report is a tangible expression of God's faithfulness, and includes financial information for both Redeemer West Side and Lincoln Square as both congregations are part of the same corporation. It also includes information from Redeemer Counseling Services and the Center for Faith & Work, which are shared with the Redeemer Network. Redeemer Lincoln Square, Redeemer Counseling Services, and the Center for Faith & Work benefited from God's faithful love in the past year. Those organizations will communicate directly with their constituents and donors. We also created a separate short Impact Report that tells the ministry side of Redeemer West Side in the 2022-23 ministry year.

This past year we emphasized our core value of 'Welcoming into Community', creating opportunities for our congregation to connect with one another in order to deepen relationships after a long season of isolation. For example, we hosted several meals after morning worship services, created a running group and coffee club, started a group for 20s and 30s, as well as used our space for support groups in the areas of grief and fertility. We are encouraged by the growing sense of connection within our Children's and Youth Ministries as well as our Community Groups, Men's and Women's Groups, classes, and Mom's Groups. We have continued the intensive cohort around race and justice as well as deepening our relationship with the Frederick Douglass Houses and partnerships with Hope for New York in which we support eight affiliate organizations.

W83 continues to be a home for our congregation and a place for our neighbors to gather. We hosted four different art exhibitions that engaged over 500 people, many of whom aren't part of our church community. We continue to serve as a concert venue for three music ensembles, and this past year launched our new "Live at W83" music concerts, which featured musical styles including classical and latin jazz. We look forward to more home-grown events like this that highlight the amazing artistic talent in our congregation as a way that connects us to our neighbors.

All of what you will find in this report is in support of our vision to follow Jesus' sacred call to love our neighbors and bring healing to our city. I am so grateful for those in our Redeemer West Side family who have partnered with us on this journey and look forward to experiencing more of our collective weakness so that we can see more of God's amazing grace.
