letter from david

Dear Redeemer West Side.

The introductory letter to an annual report encourages stakeholders to do something counterintuitive in our cultural moment: slow down and reflect on the past. Yet this practice is core to the Christian imagination: remembering the past to faithfully live into the future. This past year we reflected on the heart of the Christian life: following Jesus' sacred call (Matthew 4:19). A pilgrimage that promises life as it was meant to be (John 10:10), realized through a counterintuitive lifestyle modeled on Jesus' humility, grace, compassion and sacrifice. Hence, Jesus' statement that when we see the elements of his sacrificial death we are to remember him (Luke 22:19). So in my final annual letter as your Senior Pastor I will reach back beyond 2023 to help the Redeemer West Side (RWS) stakeholders prepare for its new chapter.

In the first five years Redeemer grew from an idea on paper to a thriving church on the UES. As a 20-something hospital administrator plunged into this venture, I remember an extraordinary movement of the Holy Spirit in the lives of individuals (myself included) who were awakened to the transformative power of divine grace. New York City was emerging from a long season of cultural, economic, and political pessimism; in many ways, it was an ideal soil for the carefully thought-through blueprint Tim and Kathy Keller brought.

The second experience was 9/11, which occurred less than three years after I joined the staff. The attack and subsequent chaos required us to transform into a hybrid between a church and a social service organization. Funds poured in from around the country as individuals who spoke little or no English sat in our hallways in need of help. Individuals who hadn't attended church in decades flooded our worship services, stretching our capacity beyond our human ability to respond.

Finally, there was the disruption of the global pandemic and the associated political and racial reckonings that, unlike 9/11, emptied our city and pews and divided us instead of uniting us. Praying daily at noon with congregants and delivering sermons to a camera lens in an empty W83 became routine as we all adjusted to another cultural paradigm shift that is still evolving.

Why remember these seasons? Because they share a common thread that is essential to RWS's future. Prayerful and well-thought-through strategies rooted in biblical core values combined with a reliance

upon the Spirit. Tim and Kathy arrived in NYC armed with a carefully constructed blueprint for the kind of church they envisioned God had called them to plant. Their faithful adherence to that vision and values, frequently under duress, was essential to the fruit experienced in the first five years. But in human terms the blueprint was a fool's errand, relocating from the suburbs with three young sons to a turbulent NYC in 1988. The only possible explanation for what happened during those five years was the gracious power of the Holy Spirit.

Similarly, those same values blossomed into a holistic ministry infrastructure with a Diaconate led by a full-time social worker. The institutional habit of caring for congregants in crisis meant that when 9/11 occurred we were able to expand that ministry city-wide. But like a decade earlier, the material, emotional, and spiritual challenges of a city engulfed in smoke and fear were above our pay grade. Yes, we worked hard, but without the power and wisdom of God's Spirit we would have collapsed under the weight of the overwhelming circumstances we faced.

Finally, the resources available to us when the pandemic emerged allowed our staff to adjust to a model of remote ministry overnight. I will forever be in awe and grateful for our staff who, while dealing with the disruption in their own lives, rallied in a spirit of creativity, collaboration, compassion, and courage to serve our city and congregation while at the same time planning for a different future. And yet, like the previous two examples, it was a poignant example of God saying to us: "My grace is sufficient for you, for my power is made perfect in weakness" (2 Corinthians 12:9).

So, as we look to the future, my encouragement is to remember your shared responsibility to prayerfully and thoughtfully plan, holding firmly to a strategy and values rooted in Jesus' sacred call to follow him in a way that tangibly reflects a cross-shaped love (Matthew 16:24). And to follow him in ways that require courage and hope, stretching you beyond your human imagination and capabilities. In those circumstances you will find that God is "able to do immeasurably more than all we ask or imagine, according to his power that is at work within us" (Ephesians 3:20).

With gratitude to the pilgrims who have preceded us, and hope for the future for those who have taken up Jesus' call to love our neighbors and heal our City.
